Pickleball Fernie Terms and Conditions

ASSUMPTION OF RISKS AND OBLIGATIONS, RELEASE OF LIABILITY, AND WAIVER OF CLAIMS
(the "Agreement")

BY ACKNOWLEDGING AND ACCEPTING THIS AGREEMENT YOU ASSUME CERTAIN RISKS AND OBLIGATIONS AND AGREE TO WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE OR CLAIM COMPENSATION.

ACKNOWLEDGEMENT OF RISK

1. The Member acknowledges and agrees with the Pickleball Fernie that the **RISK** associated with attending and playing pickleball within the City of Fernie is **CONTRACTING COVID-19**.

ACCEPTANCE OF RISK

2. The Member accepts the **RISK OF CONTRACTING COVID-19** by choosing to attend and play pickleball.

OBLIGATIONS OF THE MEMBER

3. The Member shall be required to abide by all policies of the City of Fernie and Pickleball Fernie concerning the control of **COVID-19**.
4. The Member will not attend or use the Pickleball Fernie courts if they are experiencing any symptoms of COVID-19, if they have been in immediate contact with someone who has been experiencing any symptoms of **COVID-19**, or if they are otherwise under an obligation to self-isolate or remain under quarantine.

ACCEPTANCE OF OBLIGATIONS

5. The Member accepts his/her obligations under this Agreement and acknowledges that a breach of these obligations on their part could result in cancellation of their membership with Pickleball Fernie and ability to play pickleball within the City of Fernie until the **COVID-19 PANDEMIC** is declared to be at an end by the BC Provincial Health Authorities.

WAIVER AND RELEASE

6. **The Member hereby waives and releases Pickleball Fernie and its Executive and Directors from any and all claims that the Member has or may have in the future for:**
 - a. Any loss or damage the Member may suffer due to contracting COVID-19, including sickness or death as a result of playing pickleball with Pickleball Fernie, or attending the courts within the City of Fernie, or as a result of Officers of the Club not enforcing its rules or policies;
 - b. Any removal or other discipline imposed on the Member by Pickleball Fernie results from the Member's breach of their obligations under this Agreement; and
 - c. Any injury or loss of personal belongings while playing pickleball with Pickleball Fernie.

GENERAL

7. This Agreement shall be governed by and interpreted in accordance with the laws of the Province of British Columbia.
8. Any litigation involved the parties to this Agreement shall be brought within the Province of British Columbia.
9. The Member hereby agrees to indemnify Pickleball Fernie and its Executive and Directors for all liability, expense, costs, damages, losses, claims, actions, causes of action incurred or suffered by Pickleball Fernie by reason of the Member's breach of this Agreement.

The Member has read this Agreement, fully understands the contents and the Member agrees to be bound by its terms. The Member understands that they will be giving up substantial legal rights by acknowledging and agreeing to this Agreement. The Member acknowledges that they are over 19 years of age.
